


Development Plan for the “Meadows at Haw Creek” Subdivision



Kevin Jackson, the buyer of the 26-acre property at 767 New Haw Creek Road, presented his proposed plan at a required public meeting on November 28. To the collective shock of the 200+ residents in attendance, the plan calls for 95 homes to be built on this landmark property.

This development would transform the bucolic pasture and hardwood forest into high-density housing that exceeds current zoning standards. Specific concerns shared

by residents include loss of tree canopy and animal habitat, increased traffic and safety considerations on New Haw Creek Road, and density that’s out of scale and character with the surrounding neighborhood. For these reasons, HCCA is actively opposing this plan.

The sale of the property is not yet final. Additionally, this development will require review by the Planning and Zoning Commission and others, with opportunities to make our concerns heard. Ultimately, the development will require approval by the City Council.

Your voice is needed. Please join us in our efforts to protect and preserve the quality of life we enjoy as residents of Haw Creek valley.



Haw Creek Park Greenway Campaign

The community association that brought you Haw Creek Park and Masters Park is now undertaking a campaign to bring the first-ever public greenway to the Haw Creek valley. This greenway will address a long-identified community need, providing a safe and pleasant walking trail alongside our namesake Haw Creek allowing, for the first time, public access to the creek.

HCCA seeks to raise \$78,000 to complete the greenway in 2024. Although most of the funding will come from grants, **our goal is to raise \$10,000 from within the Haw Creek community in the next 60 days.** Your contribution will help demonstrate broad-based community support, which will significantly increase our chance of obtaining grants.

The Haw Creek community is facing a significant growth and development challenge. As reported here, the 26-acre property beside the ballfields is being sold and 95 new homes have been proposed for the site. There is no denying this is a gut punch to residents who have long enjoyed the natural beauty of this landmark property. The same could be said for native wildlife inhabiting the land.

HCCA is taking steps to prevent this development as proposed. We have organized a Working Group to collaborate on action steps, published a "767 Development" page on our website to serve as a central informational resource, and reached out to our members and the public through emails and social media posts.

There will be a lengthy development review process culminating in an up or down vote by Asheville City Council sometime in the spring of 2024. Masters Park Kiosk Installed

The Masters Park Challenge, an improvements campaign begun by HCCA in 2021, was completed this fall with the installation of a new park kiosk, thanks to a Neighborhood Matching Grant from the City. This follows completion of a new parking lot and park entrance sign. All told, about \$93,000 was raised to improve this well-loved community park that links the Haw Creek valley to the Blue Ridge Parkway and the Mountains-to-Sea Trail.




Haw Creek Heritage Festival

New Haw Creek Road Sidewalk Extension Update




In what might be confused as a rerun of *Groundhog Day*, Dustin Clemens of the Public Works Dept. confirmed on Nov. 14 that construction of the long-awaited and long-promised New Haw Creek Road sidewalk extension will, in fact, finally happen in 2024.

He reported that easements will be finalized this month, utilities have begun to be relocated, and final design plans are due in December. This will enable NCDOT to issue authorization allowing the City to accept bids for construction to start in the spring of 2024. Completion of the nearly one-mile route is expected to take about one year.
